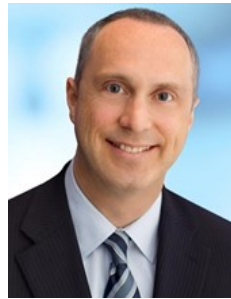
Brian Rudy, BSc, LLB

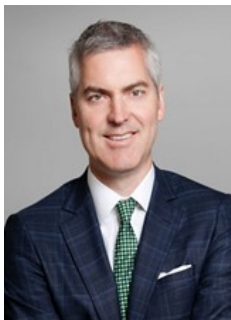
